Golf Cart Rental Agreement & Release of Liability

I AM AWARE THAT GOLF CARTS ARE MOTORIZED VEHICLES, AND CAN BE HAZARDOUS AND I AM VOLUNTARILY PARTICIPATING WITH THE KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF INJURY OR DEATH.

In consideration for being permitted to rent a golf cart, I hereby agree that I, my heirs, my distributives, guardians, legal representatives and assignees will not make a claim against, sue, attach the property of, or prosecute RBB, Inc., Brumley Management Group LLC, Turf and Industrial Equipment, and The Horse Park at Woodside, including its directors, officers, members, sponsors, employees or assignees, for any claim I now have or may hereafter have for death, injury, property loss or property damage resulting from the operation of the golf carts, whether caused by my acts of omission or negligence or any else's. In addition, it is understood that any and all insurance that I have shall be primary.

To the fullest extent permitted by law, I shall **defend, indemnify & hold harmless** RBB, Inc., Brumley Management Group LLC, Turf and Industrial Equipment, and The Horse Park at Woodside, its members, officers, agents and employees for and against any and all claims, damages, losses, expense and liabilities of every kind, including but not limited to attorney's fees, in any way arising out of or in connection with my activities under this Agreement.
